Talk and Poster Abstract Submissions Terms and Conditions

By submitting an abstract, you agree to the following:

General

1. Abstracts should be submitted via the [submission link](#) by **Friday 11 September 2026**.
2. Abstracts received after the deadline will not be accepted.
3. Abstracts must be submitted in English.
4. The abstract word limit is: title - 30 words, main text - 250 words
5. Abstracts can be submitted for either an abstract talk or poster. Poster abstracts will be considered for lightning talks.
6. Please note any abstracts not chosen for an abstract talk will be offered a poster.
7. Abstracts must include a title, author(s), affiliation(s) and summary.
8. If your abstract contains data held in the National Genomics Research Library, please provide the Research Registry Project ID. Authors must also confirm they have read and adhered to both the [Airlock](#) and [Publication](#) Policies at the time of submission.
9. The accuracy of the submitted abstract is the responsibility of the authors, so authors should prepare and proofread their abstracts carefully before submitting to ensure it is the final version.
10. All abstracts that are accepted for a lightning talk or poster may be published in the conference programme. Every effort will be made to publish the abstract exactly as submitted. Errors made on the submitted abstract are likely to appear in print.
11. All correspondence relating to abstracts will be undertaken by email with the first named/registered presenter, so it is their responsibility to communicate any relevant information regarding the submitted abstract and the conference to the other authors.
12. By submitting an abstract, the first named/registered author confirms that the submission has been approved by all authors.
13. The author agrees to present the material described and accepted in their abstract submission.
14. By submitting an abstract, the first named/registered author confirms on behalf of the co-authors that the abstract is their own original work, is not defamatory or unlawful, does not infringe anyone else's rights and that they have obtained any necessary permissions relating to images and data submitted. In addition, the first named author must ensure that he/she has the approval and copyright assignment from any co-authors and contributors involved in the work to ensure that the copyright is capable of being assigned to Genomics England.
15. By submitting an abstract, the author together with any co-authors give permission for the abstract to be published in printed materials, website, event app and social media.

16. Abstracts submitted for posters will undergo an anonymous review by the Clinical Cancer Genomics Programme Board. A limited number of posters will be selected as lightning talks for the programme.
17. The author must be available to present a lightning talk on Tuesday 3 November 2026.
18. The acceptance of an abstract does not imply provision of travel, accommodation, or registration for the event, nor any other costs associated with preparation or presentation of the abstract, or any costs associated with attendance at the event.
19. If an abstract is accepted the presenting author must register to attend the event. If the author does not register, the abstract may be withdrawn.
20. Attending co-authors will need to register independently if they wish to attend the event.
21. If the author(s) have any commercial interests or associations that might pose a conflict of interest regarding this submission, they must be declared. If accepted for presentation, the commercial interest or association must be declared on the title slide or the slide immediately following the title slide or poster.
22. The author will immediately notify the Genomics England Events Team if they are unable to present an abstract or if the presenting author has changed.

Abstract and lightning talks

23. The full slide presentation of accepted abstract and lightning talks must be submitted by email to the Genomics England Events Team (events@genomicsengland.co.uk) no later than Monday 26 October. This will ensure the presentation is loaded onto the system and is working correctly. However, the author should bring a further copy on a memory stick as back up.
24. The author(s) give Genomics England permission to film and/or photograph the presentation at the event, which may be used on the Genomics England channels.

Posters

25. All posters must be A0 size (841 × 1189 mm, unless specified), in portrait format (landscape format may not be accepted).
26. It is the responsibility of the first author/ named person to ensure the poster is on display in time for the beginning of the event and must not be removed until the end of the poster session.
27. Any posters remaining on-site at the end of the event will be disposed of.
28. Authors must take responsibility for the delivery, display and collection of their posters.
29. Genomics England does not accept liability for loss of or damage to posters.
